³⁾ This party, which was only founded in 2005, the year of entitlement, did not receive any advance payments in 2005. The assessment of state funding of 15 February 2006 is provisional; the final assessment will take place after examination of the relative limit in the 2005 statement of accounts to be submitted.

⁴⁾ The negative repayment amount shown in column 4 must be repaid immediately, since repayment obligations from 2004 are cancelled with the first advance payment due on 15 February 2006

⁵⁾ This party has not so far submitted a statement of accounts for 2004, meaning that, pursuant to section 19a (1) sentence 2 of the Law on Political Parties, no state funding may be assessed for it on 15 February 2006. The 2005 advance payments were not paid out, in agreement with the party, to avoid the costs of providing collateral.
