<sup>2)</sup> Pursuant to section 19 (5) PartG, this party's entitlement is limited to the amount of revenue it raises itself ("relative limit, cf. section 18 (5) PartG).

<sup>3)</sup> This party was only founded in 2005, the entitlement year. It is thus only entitled to contributions-based state funding for 2005. The assessment of state funding of 15 February 2006 is provisional. The final assessment takes place after the relative limit has been assessed on the basis of the statement of account for 2005 yet to be submitted.



<sup>4)</sup> This party has not so far submitted a statement of account for 2004, meaning that no state funding may be assessed on 15 February 2006; pursuant to section 19a (1) sentence 2 PartG. Independently of this, and as a result of failing to submit the 2004 statement of account on time, it has forfeited its right to contributions-based funding for 2005, pursuant to section 19a (3) sentence 3 PartG.
