"The post-MDG and SDG process"

17 or 24 April 2013, 2:00 – 5:30 p.m.

A. Background

Agreement was reached at the United Nations Conference on Sustainable Development in June 2012 in Rio de Janeiro ("Rio+20") and at the 67th session of the UN General Assembly in autumn of that same year, on the preparation of a post-2015 development agenda. This will combine the Millennium Development Goals (MDGs) – aimed chiefly at eradicating hunger and poverty and guaranteeing access to basic social amenities – with targets for environmental protection, the safeguarding of natural resources and the preservation of biodiversity. The end result will be universal "Sustainable Development Goals" (SDGs).

The new SDGs must not divert focus or effort from the achievement of the MDGs, which is still far from complete; they must be part of an inclusive and transparent intergovernmental process open to all stakeholders, global in nature and universally applicable to all countries, easy to communicate, to monitor and assess.

In the meantime a number of UN working groups and committees have been set up to move work forward on monitoring progress towards achievement of the MDGs by the target date of 2015, setting the post-MDG agenda and defining SDGs. SDGs and the post-MDG agenda are also the subject of lively debate in international civil society.

The purpose of this joint hearing of the Committee on Economic Cooperation and Development and the Subcommittee on the United Nations, International Organisations and Globalisation is to:

- 1. review the current state of progress towards achievement of the MDGs and consider which lessons for the post-MDG agenda can be learned from the successes and failures of the MDG process;
- 2. provide information on the work of the international organisations, commissions and working groups engaged on preparation of the post-MDG agenda and the SDG process;
- 3. hear and discuss suggestions and ideas about the post-MDG agenda and SDG process which have already been formulated by the Federal Government, scientific and economic circles, and non-governmental organisations working in the field of environmental and climate protection in both parts, North and South.
